Industry Innovation and Infrastructure Strategy

FMIPH has carried out various studies since 2021 in order to direct its research activities, increase its effectiveness and strengthen its focus of excellence. Within the scope of FMIPH Research Strategy and Policy determination studies, which were accelerated in 2021, it was aimed to define the direction, development and resources of research in the fields that our university was determined to be a leader at the national level, to encourage interdisciplinary studies and to further expand our institutional leadership with an institutional macro orientation.

As it is known, in the multifaceted and comprehensive study carried out with the participation of the internal and external stakeholders of the university;

Five priority research areas were determined by examining different parameters such as scientific publications, national and international projects, contracted research, patents, and the number of spin-off companies. After the determination of the fields, various meetings (workshops , sector meetings, focus group meetings, etc.) were held with relevant researchers, sector representatives and experts, similar studies at home and abroad were examined, national and international trends were analyzed, and all these were combined with the research infrastructure of our university in the relevant

fields. FMIPH Research Policy and Strategy covering the field has been prepared.

Strategy documents related to the fields of “Biotechnology , Energy, Chemical Technologies, Diseases and Treatment Approaches and Food Science and Technologies” were supported by government in all five fields. Thus, the research fields in which our university is a pioneer by entering the top five in Uzbekistan have also been approved by our country's science and technology authority.

FMIPH has been working in five priority areas for many years and has reached a certain accumulation and wealth. As a result of these studies, FMIPH Research and Innovation Strategy Document (2021-2025) was created in a more comprehensive way by researcher working groups in coordination with FMIPH Technology Transfer Office. While preparing the FMIPHR&D Strategy Document, upper policy documents were also taken into consideration.
